Archaeology / Cultural Heritage	'Immovable historical and cultural monuments of regional importance, situated in Krasnodar Krai'	No. 313-KZ of 28.7.2000	Sets out an approved list of cultural heritage sites located within Krasnodar Krai.
	'On the Designated Areas and Protection Zones of Immovable Cultural Heritage (Historical And Cultural Monuments) of Regional and Local Value Located in the Krasnodar Region'	No. 2316-KZ of 19.07.2011	This law specifies the main requirements for assigning the category of "historic-cultural heritage lands" for lands with cultural heritage; identifies procedures for their protection and use; and, defines the boundaries of the historic-cultural heritage lands located within the Krasnodar Krai territory.
Biological Impact	The Decree of the Head of the Administration for Krasnodar Krai, 'On the Red Data Book of Krasnodar Krai'	No.1202 of 21.12.2010	This decree is a basic state document which establishes a listing of rare and endangered species of wild animals, plants, and fungi, as well as some subspecies and separate populations. The book is important for organizing investigations and monitoring programs on such species and their habitats, and for developing and implementing special measures for their protection and rehabilitation.
	'On Environmental Protection at Krasnodar Krai territory'	No. 657-KZ of 31.12.2003	This law is developed based on the Federal Law on Environmental Protection and is aimed at implementing the state policy in the area of environmental protection. The law specifies objects to be protected (air, soil, wildlife, vegetation, water, groundwater, subsoil resources), responsibilities and powers of the local authorities, public and state monitoring, and control of environmental protection.
	'On Specially Protected Natural Areas of Krasnodar Krai'	No. 656-KZ of 31.12.2003	This law regulates the relationships in the area of management, protection and use of specially protected natural areas in order to preserve unique and typical ecosystems, plants and animals and perform environmental monitoring.

Biological Impact	'On Environmental Review at Krasnodar Krai territory'	No. 1205-KZ of 12.03.2007	This law specifies the powers and responsibilities of the state authorities regarding the state review in Krasnodar Krai.
Land Impacts	'On subsoil use on Krasnodar Krai territory'	No. 101-KZ of 10.10.1997	This law regulates legal relationships in the area of the use of subsoil resources.
	'On natural therapeutic resources, health improving areas and resorts of Krasnodar Krai'	No. 41-KZ of 07.08.1996	This law specifies the terms of therapeutic resources, health improving areas and resorts, the responsibilities and powers of the local authorities, and the procedure of use of therapeutic resources in Krasnodar Krai.
	'On the basis of regulation land relations in the Krasnodar Krai region'	No. 532-KZ of 05.11.2002	This law specifies the terms and conditions of assigning the land categories, transferring land from one category to another, assigning the authorities responsible for land categorization at different levels, and specifying the terms and conditions of transfer of land ownership.
Impact on Atmosphere	'On atmospheric air protection in the Krasnodar Krai territory'	No. 734-KZ of 02.07.2004	This law specifies the general policy for air protection, powers and responsibilities of the authorities, the procedure of establishing emission standards and limits, and requirements for developing emission reduction plans.
Waste	'On Production and Consumption waste'	No. 245-KZ of 13.03.2000	This law is based on the Federal Law on Consumption and Production Waste and is aimed at mitigating adverse impacts of wastes on the environment. The law specifies types of wastes, their hazard class, and activities related to waste handling, and responsibilities of the authorities who establish waste limits and issue waste permits and licenses.
	'The reference with a firm household waste in the territory of Krasnodar Krai for 2009-2013'	No. 1649-KZ of 29.12.2008	This law approves the Regional Program 'Solid Domestic Waste handling at the territory of Krasnodar Krai' for years 2009-1013.
